f. Advisors- Hi Everyone! I am going to start with the first little bit of bad news. While enrollment is up but technically it is down, we do not have reserve numbers yet. I will send you an email with that reserve number once I get it. Basically enrollment is technically up but enrollment that pays sga fees are down. Meaning more dual enrollment students but we can talk about that later. So our budget is lower than we thought, but we have a reserve which is good. That is what its for. You will probably remember the senate passing a bill for Bike Racks on Campus a few weeks back. The administration had asked that SGA purchase a bike rack, and then they would pay for the concrete. Senator Rusnak put a great deal of work into this bill, and scoped out the area and chose a low profile bike rack that held 12 bikes that she thought would work best. Unfortunately, the university has now said that bike rack does not meet university standards. They have proposed a loop bike rack that holds 9 bikes and is powder coated blue. The University's chosen rack is about \$500 more than the original bill. Because of the price difference, someone would have to reintroduce the bill in order for this to happen. Senator Rusnak has said she is not really interested in rewriting the bill. If anyone else would like to you can let me know and I will send you the universities quotes. If no one is interested then the bike rack will not go up, and the money will return to the senate. Feel free to discuss this in open forum, and I will answer questions after the meeting. Congrats on a great semester: . Winter Staycation on Dec 12th Annual SIL training event, all four branches meet together and we talk about what each other are doing, I want to talk about holding each other accountable and our mission and at the end of the day we are under the same umbrella, and we need to start acting like it.

b. UNITY Bill- Nicky Cao Author and Kia Jackson Sponsor-The bill is to buy pronoun buttons for people to wear so that people are aware of pronouns on campus, the purchase of LGBTQ+ supplies is necessary to the UNO community because ; often times transgender students are misgendered by friends, classmates, and UNO staff. The pronoun buttons would help transgender students be gendered correctly. The use of pronoun buttons will also help normalize the conversation with cisgender folks about the concept of pronouns. The pride button collection will allow for queer and trans youth to wear a button to A) mark themselves visible as gueer/trans B) allow them to converse with other folks who has the button on or converse with folks in the community C) have pride in themselves! The non-binary flag is a flag that UNITY does not have. UNITY already has a transgender pride and queer pride flag, and to be more inclusive of people who do not identify in the gender binary system. Cognevich VPLA- SIL sends out newsletters with events happening every week to everyone on campus, so talk to them about it.

Cao COLA- We should really look up bills and information in advance so we don't waste time to slate things that we know nothing about. We need to know what we are voting for so if we don't we need to table not vote anyways.

Johnson- I think we should prioritize pronouns in SGA, we should add them to the name plates. Cao COLA- I agree and to have campus orgs have pronouns on name tags. Maybe orientations have pronouns and all events have them. Maybe write a resolution for every organization to have pronouns.

Johnson- Privateer Camp did have pronouns i thought that was great.

Heuer COB- I haven't been present for the past meetings but we should not be voting on people who aren't here and not present or that we know nothing about. There was a previous conversation about the value of having a senator that wants to be here verses a high number of senators, and I think that statement holds a lot of value for what happened today with those appointments.

Cao COLA- Our Blake Trans Lives Matters Banner was maliciously ripped off the wall and somehow it was someone who knows where the cameras are because they dodged every camera and managed to rip it off. No one picked it up. Maybe SGA should make a statement about it. Johnson - I work in the UC, we will try to improve the cameras in the UC, I am sorry that that happened, I don't think that it was planned. It was a flaw in the camera system.
