But I just wanted to give a quick little thing because I actually talked to Miss Anne Lockridge, who is the Senior Director of Financial Aid, because a lot of people have been asking questions about refunds, this is going to be very basic, but the main reason that these situations happened with the refunds is that there's actually a lot of stipulations that come in with students getting their aid. And it's also different depending on what type of aid you're getting. If you're getting federal aid, like your federal loans and Pell Grants, it's actually can be done a lot more quickly, because they don't actually require them to do the Census Enrollment Verification. But if you're getting a TOPS scholarship through the state, or a UNO scholarship, they actually have to do an attendance verification. So that's what that "14th day of classes", that's not necessarily the magic day that refunds automatically go in, unfortunately. And sometimes I feel that we've kind of been conditioned to think "14th Day of classes, I'm gonna get my money," but unfortunately, that's not always the case. Um, so I just wanted to bring that to everyone's attention and maybe pass that along, if any students are talking to you about refunds, just because, um, that's very important information for people to know. And then of course, once it gets processed by financial aid, they don't actually give you the money, they actually have to send it to the Bursar, and the school has to get paid first before- before the money can actually hit your account. Thank you.

So could you please fill that out? And then, some people have questions. So I'm just going to answer those really quickly. As far as what week y'all would be meeting, I don't know that yet. So now that I have you guys' availability, I'm going to reach out to the Deans and get their availability, and then I'll schedule the first initial meeting from there. So, as soon as I get that handled, I'll make sure I let you guys know, and then the other question was, um, what would be a good starting point when meeting with the deans and first, I would say, you know, maybe just like an introduction, and just like a general cons- consensus of what you guys are comfortable with, as far as meeting and discussions, and also what the Deans are comfortable with. The court has been petitioned, the court docket number is #1-22-1. The court has been partitioned in regards to a dispute within the Senate, pretending to the procedures that was conducted. With that being said, the Senate has been notified of this matter. And this is Unless- I mean- a judicial process, so we must maintain the integrity of that at all times. So you guys are allowed to ask questions, but my response will be limited. And I will go on into how this hearing will take out. So prior to a hearing, a party in action can request to have someone else present before the court. This credit- this request must be submitted to the Clerk of Court at least 48 hours prior to the hearing, it must be in written form. So if you want to speak, or be speaking, on behalf of you must email the Clerk of Court within those timeframes allotted. You can see that on the Judicial Rules and Procedures. Interested parties wishing to speak during our hearing must submit a request at least 24 hours prior to said hearing. This request must be in written form and include the individual's reason for wishing to speak. Just because you submit a request does not mean you will be granted the opportunity to speak. So please keep that in mind. And the last point, the court recommends that the defendant action submit an answer to the complaint, see form CS-002, to the SGA Clerk of Court, any such filing must be made no later than 48 hours prior to the scheduled hearing date. So you guys will be notified of this matter soon by the Clerk of Court that you have any questions pertaining to documents and things like that, please reach out to the Clerk of Court. And I do yield the rest of my time for questions.

Jordan Moss, vice president, so I got the information from the referendum and I wanted to give it to you guys. So, the current athletic fee for a full time, so 12 or more hours is \$100. For one to three credit hours, it's \$31.94, for four to six credit hours is \$62.34, for seven to nine credit hours is \$78.10. And for 10 To 11 credit hours is \$93.98. And the proposed student experience fee will be a flat fee of \$300 for part time students, and a flat fee of \$400 for full time students, so for full time students is a \$300 increase. And as far as the percentages 90% of the revenue should would go to the athletic department 6% would go to the marching band 1% for student activities, 1% for retention programs and 1% for an intramural and Club program, and then another 1% for student diversity programs.
