Dr. Carolyn Golz 03:03

Thank you so much. Thank you, Brendan. I'm not so great with Robert's Rules, so I appreciate that. I just wanted to come and introduce myself. I'm Carolyn Golz, I'm the Dean of Students. And so I get to work really closely with student government. I, and the president, and the provost meet on a monthly basis with the SGA leadership. And that is our way of making sure that the administration and SGA have a great working relationship so that we know that you- the representatives of the student body- we know what you're thinking, we know what your concerns are, and we're able to work together on trying to solve those concerns and also bring new projects and programs to campus. So I just wanted to introduce myself, thank you for your service. I can't tell you how excited I am to see this many people together in this room. It's been two years since that has happened. And so every time I'm in a space that's full, partly I'm a little overwhelmed because I've been by- behind my computer for so long, but also just excited that- that you're all interested and willing to get engaged and to participate and that you're looking for the engagement that we want to provide so thank you all. Dr. Carolyn Golz 04:52

Sure. So, the Dean of Students office primarily serves as kind of a hub resource to help them get connected to other resources on campus. The main services we provide in the Dean of Students Office is the Privateer Pantry. So any student can take advantage of the pantry. We provide supplemental nutrition. So that if students have to decide "Do I put gas in my car this week so I get to class or do I buy groceries?" Hopefully we can help with the groceries so you have more money for gas. So we'll take your online orders and we'll pack your bags and let you know when you're ready and you can come pick them up. But then as the Dean of Students, I also supervise all of the other areas of Student Affairs. So that includes Counseling Services, Career Services, Health Services, I'm always going to forget someone- Student Involvement and Leadership or new office of- Yep Woohoo! Our new Office of Orientation and Transition Programs, Residential Life. We have three TRIO programs, which are federally funded grant programs. Several of them do outreach to the high school students to help them graduate high school and get into college with student support services- through a program that is for students who are here, and then we have McNair which is for students who want to go into graduate school. And, who am I forgetting? I know I'm forgetting somebody. Student Accountability and Disability Services so don't tell Amy King I forgot about that.

Diversity Engagement Center, yes. Right across the way so Dr. Desiree Anderson is our Associate Dean of Students for- Associate Dean for Diversity and Student Affairs. So she oversees the Diversity Engagement Center? Thank you for that. Don't tell her I forgot about her.

Has it been a good year so far?

Dr. Carolyn Golz 06:55

Yes, so far. [Laughter] Last year was hard. This year, to make it this far, we're doing really well. You might remember by this time last year, we had Hurricane Ida. So we're doing great, we're gonna keep thinking really good thoughts for- really good thoughts. Yes, we're doing great so far. I hope you all have a great semester. Please don't hesitate to reach out if you need anything. Or if we are not the right place, we will help you get to the right place. And so we- our goal really is to break down barriers and help you all be successful. Yes?

So what's your schedule? What do you do on an average day?

Dr. Carolyn Golz 07:37

I sit in a lot of meetings. The majority of my time is in meetings. So right now we have Provost candidates on campus because our Provost is stepping down and returning to the faculties. So I was in two meetings today for that, and I had a Webinar today from the Louisiana Department of Health about MonkeyPox. I'm also the primary COVID Coordinator for campus, so when you submit your COVID Reports those come to me, that's why- the mask, I know who's got COVID on this campus. And I know

how close I was to them recently. So I try always wear my mask indoors. Because I- also knocking on wood- have made it this far without COVID and my goal is to make it as far as I can. And then, you know, just all kinds of meetings with each of the different directors in Student Affairs, and then also other areas across campus. So a lot of needs, but I also meet with students right? So, I get referrals across campus, from a faculty member who may notice that a student is struggling in class or has missed class for the last three weeks. I want to know, First, the student is alive and then Second, why have you not been going to class, what is getting in the way of that and how can I help you? It may not always be me reaching out but I coordinate a team of people who will do that outreach.

I don't, and before I came here, I sent another email to ask that question. This should be an easy answer. And I don't know why it's not but I promise you you're working to get it.

Yep, absolutely. Yeah, I know you all- I know you all need that number, right? Again, I don't know why we don't know it. But we're working to get that. Unfortunately, when they close the books, they close us out of last year's books so we can't go back in and see what was there at the end of the year, and we have to wait for Business Affairs to populate the budget for this year. And that's when the number carries over. So I'm still waiting. I mean I don't even know my budget yet. I mean, I know my budget but I don't- I haven't been able to go in and move everything around yet.

There is a blank paper that says, really messily, "Demerit" that will be filled soon, the Demerit system, and there's a volunteer sheet. So the volunteer sheet is, I think we've mentioned this maybe in the past, but you're able to get volunteer hours put onto your transcripts, which a lot of students didn't know about. So make sure that you're all able to utilize that. So you can just fill it out and then our Volunteer Coordinator Amber, who works in the office, will be able to help you facilitate getting that on your

And what we're able to do is we're able to- with Amber's help - is go to- Actually let me get the Advisors for you. Who do we go to to put that on the transcripts?

But Amber is the reporter of volunteer hours. She records them and she reports them. So just, once you do community service hours, just let her know. Make sure you have a signed copy from the person who was your- who was your supervisor during that time while you did it, and then just turn to documentation to her. And I'm sorry, for recording purposes, Advisor Courseault.

We do. Hey y'all, happy Wednesday. That response says everything I need to know. [Laughter] It is so nice to see this room so filled. We're gonna try to keep this report brief. I just wanted to go over the Rules and Procedures for tardiness as well as for absences just so that y'all know. If you are late, you must ask to be recognized. That would be Azizah's role, because we don't really- in your rules and procedures, we don't have anything that talks about it. However, I guess if you're a Committee Head, you set your expectations and you let us know what your expectations are. If you need any assistance, we'll help you.

Chloe Metzler, Sophmore at Large, who would we email or speak to, to get those numbers of absences or tardies?

And just to add some more clarity to Senator Hymel's question, excessive tardi- So yes, it is correct if you have three absences-unexcused absences in Senate, you are excused from Senate. Yeah, I would just- I would consider it to be like, sorry, Azizah Hinnawi. I consider it to be more like any attendance demerit would add up and this will also be a little bit more clarified, when Angelo brings forth the Demerit system, it does go into more detail, which is why we kind of chose to not put so much detail into the rules over the years, because this Demerit system will go into that and you will see that later on. Pretty much, just, absences, tardies. They go hand in hand because, think about it like this. You walk in, and we've already gone through all the reports. Vice President Moss 43:51

Vice President Moss, Point of Order, Angelo wants to give his statement. He's on the phone because of the Wi-Fi situation so I'm gonna put him there.

Parliamentarian Hymel 44:02

Jenna Hymel, motion to extend questioning by three minutes.

Senator Peters 44:08

Adam Peters, College of Engineering, I second the motion.

President Charles 44:23

We don't want it to be so punitive that you guys think, you guys- you know, don't be concerned about this. It's really just for the sake of clarity. So what we have in the code of decorum and order- I don't really want to call it a demerit system- we should call it like it's just a code of order. So we have- if you're not present for the call of roll, and arriving between 5 and 14 minutes late after the start of SGA

meeting. So after you know 14 minutes and you move to the 15 minute mark, it will be considered an absence. You guys will get this document, I promise but we have to make sure that all the legalities and everything else is correct. Feel free to like email me certain questions. Yeah, it's not going to be- I'm sorry, Azizah Hinnawi- it's not going to like go into- What's the word?

Senators 45:46

Retroactive.

VPLA Hinnawi 45:46

Yeah, it's not gonna be retroactive. Okay, we do not have any old business or new business, straight to Open Forum. This is where we discuss matters pertaining to the betterment of SGA.

Daniel Hunsaker, Senior at Large, I noticed more often that, you know the Library is just- does not have great hours. I really miss the 24 hour system and as we get toward midterms it's very important that we have extended hours so I was just wondering like what- what can we do to fix that?

Vice President Moss 48:06

Vice President Moss, when me and President Charles had our meetings with- Dean, the Library Dean, he did let us know that their hours were due to staffing issues. So during the regular school season, unfortunately they cannot extend the hours, but I will reach out on your behalf and ask about if they have plans on extension during Midterms. Because I do know that it's vital to- you know- our studying and our success in school. So I will reach out regarding midterms, but he already did let us know like as far as now it's like kind of like- staffing and financial issues.

Senator Carbo 48:54

lan Carbo, College of Business Administration. Point of Order, I've already taken like three of my midterms. Like- so three of them- Two of my classes only have like two tests. So taking one of the test equals one of the midterms. But like I also agree that at least for finals, it should definitely have extended hours because I know that's especially a time that everyone is trying to get in as much studying as they can.

So let me just say something real quick. So with midterms, it's not something as final as like one midterm week, which could be the situation, because last semester when they did extended hours for midterm season. It was the week after I was already done on my midterms. So there's not really a way to put a number on that. But for finals season I think it is much more outlined. But we'll definitely still get in touch with them and see if we can get anything

President Charles has something to say.

President Charles 50:03

Hey y'all, once again, like I just want to reiterate what Jordan said like the library, nor does the university you know- we're not in the best fiscal standpoint. And we all understand that students have needs and that we need the library open, but the reality is, we can't also ask for students to work for free. And that's, you know, that puts us in a juxtaposition and I certainly will reach out to the library you know, to see if we can extend hours maybe for one day, but we can't also ask students to volunteer to monitor the Library for free labor. So before we, you know, advocate for something like that, which I totally agree I have finals as well. We just need to, you know, make sure we're communicating with

each other first, but I definitely want to reach out to maybe Dr. Nicklow and see if he can maybe help the library budget or something like that just to see. That's all.

Brendan Mott, College of Liberal Arts, I actually do have an extra point about that. And this might be a like a safety concern, I can understand why it's not a thing. But I thought it'd be a good point to mention that some programs have 24 hour access to their particular building. And technically, you can call UNOPD if you don't have card access and say "I need to get into this building." They might let you in. But I think the issue is is that if you- if the library is not 24 hours, why can't students of every program have access to their building 24 hours? That the buildings don't have staff 24 hours. I understand the library being staffed 24 hours, because there's books and materials that can get stolen really easily, but I don't- think that could be possibly make a way of trying to get make access to other buildings 24 hours? Like I know engineering majors have 24 hour access to the engineering building. why can't everybody have access to their building 24 hours?

Senator Peters 51:44

Point of information for the engineering. That has to be requested. That is not given, the engineering building locks at 7pm and you have to request keycard access to the building. It is not just handed out to students

Senator Martinez 52:06

Oscar Martinez, College of Sciences, I think the big issue is some of the buildings like the chemistry building and the biology building have sensitive chemicals inside. So- and also the science building have sensitive- sensitive things inside. So I think if we actually request 24 hour access, it would be problematic because a lot of those rooms aren't locked after hours. But I like where your head is at. So yeah.

Parliamentarian Hymel 52:34

Jenna Hymel, Parliamentarian, I work in the office that gives a key and hard access. Therefore, what I know a little bit more about it. And the reason that we can't give stuff out, like Senator Peters said, it's requested. Also, I know some people sporadically have access to like the library after hours in the Engineering Building after hours. Also that is because they have actual card access, instead of actual key locks a lot of our buildings just have the key locks such as liberal arts, so there is no way for you to get access without printing every student a key

Senator Lemons 53:22

Cooper Lemons, College of Liberal Arts. Like they said for Governance, I don't have a report for Finance. But I did email out to everyone and sort of introduce myself. And we'll be going over the upcoming bill that Jenna also covered. Does anyone have any questions?

Vice President Moss, I really like your guys' idea, so I think this will be good points for you guys to mention with your individual meetings with the deans on how things like maybe 24/7 access at request, for certain days where they can have professors stay behind for longer access to the building and do

your things. So please hold on to your ideas and make sure you mention those because those are really good ideas.

Point of Information, the computer science department, the third floor of that building building, also is 24 hour access. So, definitely look into it when you have your meetings with your Dean as Jordan just said. Does anyone have anything else to say?
