So they want to work with us if they're if their students have concerns that may be bigger than just the halls.
- But I'll also address some concerns some senators talk to me about when it comes to guest policies in Pontchartrain Hall and other policies like that in general. So first of all, I'm gonna say that the answer that I got might be one that everyone will like, but it's the answer that they gave me. First of all, just open guest policies are actually not as common as you think. If you do rent an apartment, there often is still a guest policy where you can actually get evicted if you keep having people over when you're not supposed to. There also places even New Orleans where you do have to sign in your guests at a front desk when you walk into the building. It is not just a thing that happens in residence halls. And then also another thing is with Mardi Gras, that was done more for the resident safety according to them, not the safety of like the people

who possibly go in there are concerns that guests may like attempt to possibly be rude or

rowdy towards other residents, especially during Mardi Gras season. And that was the answer I got. Now profiting off of it, They just said that was their only way, that was a compromise they made because they used to completely ban guests for Mardi Gras.


